- **Beagle:** 24 pounds, 14-year lifespan; intelligent; independent; social; high energy
- **Chihuahua:** 3 to 6 pounds; 18-year lifespan; lively; loyal; healthy; prone to barking and nervousness
- **Boston Terrier:** 10 to 25 pounds; 12-year lifespan; smart; affectionate; prone to breathing difficulties
- **Otterhound:** 50 pounds; 12-year lifespan; friendly; moderately active water dog
- **Cavalier King Charles Spaniel:** 13 to 18 pounds; 9 to 14-year lifespan; good watchdog; gentle; fairly active
- **Cocker Spaniel:** 20 to 30 pounds; 12 to 15-year lifespan; loyal; moderately active; likes to be by your side
- **Pembroke Welsh Corgi:** 30 pounds; 11 to 13-year lifespan; very smart; herders; friendly; moderately active

Your Legislative Corner – The 2019 Agenda


HB 1139, introduced by Representative Woody Burton, provides for a 13th check in 2019 and 2020. The bill—as introduced—provides for a 13th check in the same amounts as recent years. Your RIPEA Board of Directors of course supports the bill, but believes each category should be increased \$50, as we put forth in our November 2018 Communicator. When the bill is heard in committee, RIPEA will propose an amendment to increase each category \$50.

As of the date the newsletter went to print the bill was passed by the House and sent to the Senate. RIPEA will try to add the \$50 in the Senate.
